NEW STUDENTS

Welcome to the 2023-2024 season at The School of Canadian Contemporary Dance Theatre! If you are/your child is a new student, see step by step registration instructions below and if you require assistance or clarification, please email schoolofccdt@ccdt.org for more information.

Step 1: Register Your Dancer(s)

This online form will allow you to register your dancer(s) in our system and create a login to the online portal which will allow you to view your balance, keep track of your schedule, and submit absences. YOU WILL NOT CHOOSE AND REGISTER CLASSES AT THIS TIME (SEE STEP 3)

Step 2: Review Our Policies

You will need to sign off on all of our policies in the online portal, but we have included them all here for readability. (See page 2) In order to officially *opt-out* of our email list or photo consent you will need to email the office directly. Step 3: Complete and Submit Class Selection & Payment Form

See attached schedule (page 3) and subsequent Class Selection and Payment Form (page 4). Enter all relevant information. If you require assistance or advice on choosing classes, please do not hesitate to contact us. Send the completed Class Selection and Payment Form to schoolofccdt@ccdt.org for review. Please do not send an etransfer or cheque at this time, wait to be contacted by the school administrator.

Step 4: Approval and Payment of Fees

After your dancer(s) have been registered in our online system and your Class Selection & Payment Form has been approved by our office **you will need to pay your fees in order for your registration to be complete**. Either full payment or a first installment is required upon registration. See Class Selection & Payment Form for payment method options.

All policies will need to be signed off on the online portal but they are included here for easier readability.

Release Form

I hereby certify that I am/my child is in good physical condition and is able to participate safely in dance classes. All current medical conditions are outlined on this form. I understand that classes will be conducted in the safest possible manner by trained professional instructors. I understand the inherent risk involved in the physical activity of dancing, and that despite precautions being taken by the studio, accidents and injuries may occur. By signing this release form, I assume all risks related to the use of any and all spaces used by SCCDT. I agree to release SCCDT from responsibility including all teachers, dancers, accompanists, staff members, and facilities used from any cause of action, claims, or demands now and in the future. I will not hold SCCDT liable for any personal injury including but not limited to: scrapes, bruises, cuts, sprains, fractures, broken bones, concussions or death or any personal property damage/loss, which may occur on the premises before, during or after dance classes.

Should in-person classes not be possible and proceed online, I understand the risk involved and potential obstacles in my home, and assume all risks related to the virtual classes. I release SCCDT and its teachers from liability in case of accident or injury during an online/virtual class. I/my child will notify the teacher immediately if an injury should occur, and seek medical attention. I/my child will not participate if they are unable to do so safely. During online/virtual classes, I will ensure my child has adequate supervision, and acknowledge that I am are responsible for their safety while participating from home/outside the studio.

Additional Health & Safety Agreement

- I understand that if my child is feeling ill with symptoms including but not limited to fever, cough, sore throat, loss/decrease of taste/smell, or difficulty breathing, they must remain home, and I will refer to current Public Health guidance in regards to testing and isolation and/or contact a physician for clearance to return to the studio.
- I understand that if my child or anyone in our household has tested positive for COVID-19, or if we have been directed to self-isolate for any reason, they will not be able to attend until cleared by applicable Public Health guidance.
- I understand that parents, guardians, siblings, etc. may not remain in the lobby during classes.
- I understand that appropriate measures are being taken to protect my child from contracting COVID-19 while attending class at SCCDT, and release SCCDT of any liability should my child contract COVID-19.
- I understand that COVID-19 policies may be updated throughout the year to reflect the changing situation and evolving Government regulations.

Withdrawal/Refund Policy

I understand that all fees are non-refundable. Students withdrawing must provide valid written notice of withdrawal before the next installment is due; otherwise payments will be processed and no refund will be granted. Should a resurgence of COVID-19 require SCCDT to cease in-person classes, classes will continue online, and no tuition refunds will be given.
